Newsletter

The nature and purpose of the processing:

Your data will only be used to send you the subscribed newsletter by e-mail. Your name is entered in order to address you personally in the newsletter and, if necessary, to identify you if you wish to exercise your right as a person affected.

For an effective registration we need a valid e-mail address. In order to verify that a registration is actually made by the owner of an e-mail address ,we use the "double-opt-in" procedure. For this purpose, we log the ordering of the newsletter, the sending of a confirmation e-mail and the receipt of the answer requested hereby. Further data is not collected. The data will be used exclusively for sending the newsletter and will not be passed on to third parties.

Legal basis:

On the basis of your expressly granted consent, we will send you our newsletter or comparable information regularly by e-mail to the e-mail you have provided.

You can revoke your consent to the storage of our personal data and its use for sending the newsletter at any time with effect for the future. You will find a corresponding like in every newsletter. You can also unsubscribe at any time directly on this website or inform us of your revocation via the contract option given at the end of this data protection information.

Storage period:

The data will only be processed in this context as long as the corresponding consent has been given. Afterwards they will be deleted.

Provision prescribed or necessary:

Use of Google Analytics

The nature and purpose of the processing:

This website uses Google Analytics, a web analysis service of Google. Google Analytics uses "cookies", which are text files placed on your computer, to help the website analyze how users use the site. The information generated by the cookie about your use of this website is usually transferred to a Google server in the USA and stored there. However, due to the activation of IP anonymization on these websites, your IP address will be shortened by Google within member states of the European Union or in other contracting states of the Agreement on the European Economic Area. Only in exceptional cases will the full IP address be transferred to a Google server in the USA and shortened there. Google AdWords

Our website uses Google Conversion Tracking. The operating system of Google AdWords services is Google LLC. If you have reached our website via an advertisement placed by Google, Google Adwords will place a cookie on your computer. The conversion tracking cookie is used to generate conversion statistics for those advertisers who have opted in to conversion tracking. Customers are told the total number of clicks on their ad and were redirected to a page with a conversion tracking tag. However, they do not receive any information that can be used to personally identify users. The cookies lose their validity after 30 days and are not used for personal identification purposes.
